## OWN Oracle to disband; Visitors Center to close

After many years of service in the Oracle, and surrounding communities, OWN-Oracle Women's Network, doing business as OWN Oracle, will be disbanding its non-profit organization. OWN Oracle has been a non-profit since 2014, but had been a loose organization that promoted women in business since 2004. The group started out as the Oracle Women's Network, a more women-in-business-oriented organization. When they became a non-profit, they switched the name to OWN Oracle, with a bigger vision of connecting with and helping all organizations and businesses of the area.

This disbanding of OWN Oracle comes after a long time of conversations within the organization. Many of the members are older, and with some moving away, and some moving on into new stages of their lives, they have

found it best to bring the non-profit to a close. Since the pandemic in 2020, they have been searching to bring on new members, but have found it difficult to find those willing to give their time to the community, who aren't already doing it in one way or the other.

Alicia Bristow, OWN Oracle president for the past 10 years, commented, "When you take on volunteers, and you train them, you have to be ready to let them go as well. You can't expect them to stay forever. There is a season for things, and eventually the season runs out." OWN Oracle has done many things in its many years of service to the community. They pushed for the county to inspect the cemetery, because of a hillside that was washing out, with concern it would disrupt the graves. The problem was tended to and a road was paved. OWN Oracle set the former skate park up to be a community garden, and then found a group to take it over. They hosted numerous seminars, and courses designed to help local people understand and learn business tactics, tools, and skills. OWN Oracle was also responsible for maintaining and operating the Oracle Visitors Center, which was designed to be a hub for tourism info. Unfortunately, since it was run by OWN Oracle, and no other non-profit has decided to take on the upkeep and operation costs, the Oracle Visitors Center will be closing its doors. The Oracle Community Center will be taking over and continuing the Oracle Tourism web page.

"It makes me sad that it's not going to exist any longer, but I keep reminding myself that there's a season for everything," added Alicia Bristow, who wanted to thank the Copper Corridor Economic Development Coalition, SaddleBrooke Ranch, Oracle Community Center, Founder and past president Sue Parra, and all of the members for their help.

On Jan. 25, members that could attend, had a final group dinner at Nonna Maria's. The night carried many mixed emotions for all who were in attendance.

The combined \$44.7 million project will require multiple full highway closures on US 60 between Superior and Miami for blasting operations as crews work to construct new bridges over Queen Creek and Waterfall Canyon. Motorists should plan for as many as three closures a week, starting at a date to be determined within the next several weeks, and continuing until autumn. The closures, when required, will occur from 9 a.m. to 2 p.m. Tuesdays, Wednesdays and Thursdays.

During the closures for blasting, crews will work to shift the highway 65 feet to the east and align it with the new Queen Creek Bridge. Also during the closures, crews will reconstruct the Waterfall Canyon Bridge just east of the Queen Creek Tunnel.

During the closures, motorists will detour on state routes 77 and 177 through Winkelman. This will add up



### It's official.

On Jan. 23, members of Superior Town Council, Rebuild Superior, Resolution Copper, Superior Chamber of Commerce, Central Arizona College and Cobra Valley Institute of Technology all gathered at the Superior Enterprise center for the ribbon cutting of the Enterprise Center's welding facility and program.

Beginning the ceremony was Rebuild Superior's president Manny Guzman, who said, "This has been a long time coming with a lot of partners involved to be able to inaugurate this space. I think it was two years ago that we celebrated returning the building to the town government and the people of Superior. It is a blessing to be here to restore it to its place. This is the first time in 24 years that a course for credit is being offered at this complex, so let's celebrate that."

"Today is a culmination of so many wonderful things," said Superior Mayor Mila Besich. "In 2016, we had a very bold, bright and visionary council, and an amazing town manager, and we said that, not only did we want to solve our problems that we had, but we wanted to do something big and bold for our community, for people that have been here for many generations, and those that are new to our community. We set up a vision, that we would care about education, Pre-K through 20, that there would always be opportunities for lifelong learning.

"We decided that we would open a multi-gen center, and Todd boldly told us, 'You have about \$4 million to play with, and that's only if you can get Resolution [Copper] to play with us and be our partner.""

She continued, "Our council wanted to, at first, build a new building out by the current school district, and Todd told us very soon, 'You don't have the money to do the Earth work', and we started down the road building our partnership with Resolution, which officially began right before Valentine's Day in 2019, with agreements that were really unique and bold for any mining company to contribute to. We started designing a multi-gen center, and it was going to go to our Junior High, where town hall is at now. And COVID happened. And rapid inflation happened. And this dream pretty much almost fell off the rails. We almost didn't think it was going to happen.

"When council took another bold move, and suggested let's talk to Mr. Cardon, and see if he would sell us the (old high school) building,

and here we are today on what is a new ribbon cutting, and there will be several because the building isn't done yet, but our commitment and vision is to empower our local residents, to help our young people to be able to stay here. As Manny said, our community has not had access to skilled job training without having to travel outside of this community for 24 years. Besich called for a round of applause for everyone who made the new welding center a reality.

Closing out the speaking section of the ceremony was the Enterprise Center's Director Arlynn Godinez.

"To build something like this, as impactful as this," she said, "there are so many people to thank, because it wouldn't come about without the partnerships we've developed.

In developing this program we worked with Central Arizona College and Cobra Valley Institute of Technology. We started small, we started with just 10 participants, but our vision is much larger than that, and with the partnerships we've developed, and the core that we've developed, I think the sky is the limit. This is just one aspect of a greater vision that we have, our hope is that we can be the hub for workforce development for the entire region, and that's what we're going to work tirelessly to do."

Another ribbon cut, celebrating Superior's and the region's continuing quest for a thriving and prosperous future. Congratulations to the Town of Superior and the Superior Enterprise Center on the welding program and facility, continue to do great things!



to one hour to the trip between Globe and Superior. By providing consistent days and times for these full closures, ADOT is providing a reliable schedule for those who travel between the Superior and Globe areas.

Toward the end of the project, a multiday closure of US 60 will be required to finish realigning the highway with the new Queen Creek Bridge.

The new Queen Creek Bridge will span 763 feet and feature one lane of travel in each direction with 4-foot-wide shoulders. The replacement structure for the Waterfall Canyon Bridge will span 107 feet.

Once the Queen Creek Bridge is completed, crews will dismantle the existing structure, which opened to traffic in 1949. While the bridge remains




