ur great town has entered 2024 at hypersonic speed, and we are excited about the many major milestones we have celebrated in January alone!

First though, it is important to note that we ended an equally productive 2023 with the signing of our second multi-year Community and Economic Development agreement with Resolution Copper. This agreement provides \$700,000 a year for three years to help us continue our community and economic development work as well as additional funding for our Town of Superior Youth Council and the First LEGO Robotics Team.

At our January Town Council meeting, we approved our annual audit. We all are very proud to have approved a clean audit with no substantial findings. The audit also reported that the valuation of our town increased by \$218,000 and we now owe less than \$1 million to our HURF imbalance! This is remarkable progress and reflects the fiscal responsibility and checks and balances we have instituted in the past several years to ensure our fiscal health continues to be sound despite working with a very meager budget and lean staff

Superior's Town Council also unanimously approved a Good Neighbor Agreement with Resolution Copper which

has been a focus of several years' diligent work to reach this important milestone. This agreement formalizes the agreements between Resolution Copper and the Town of Superior as well as other nonprofit organizations and Copper Corridor communities that have had various agreements with Resolution Copper. This new Good Neighbor agreement is the first of it kind for Superior and will help to ensure that the agreements and relationships we have today will be sustained through the life of the mine.

Also in January, volunteers joined with Arizona Water Company to install the plants and part of the landscaping at the Coleman Alley Park on Main Street. This park was planned through funding from the Water Now Alliance, Arizona Water Company, Resolution Copper, Rebuild Superior Inc. and, of course, the Town of Superior. This park will serve as an educational park to teach us about "green infrastructure", which entails the design of parks, curbs and other infrastructure to better guide water safely back into the aquifers and drainage system.

Yet another major feat we accomplished in January was the official opening of the Welding Lab at the Multi-Gen Center. Ten local students registered for the welding course through Central Arizona College, which began on Jan. 16, 2024. Local leaders gathered for an official ribbon cutting and celebration this month. This achievement resulted from the many partnerships we have built to bring job training programs to Superior. It has been 24 years since residents and students in Superior had access to skilled job training programs. Thank you to Resolution Copper, Rebuild Superior Inc., Superior Enterprise Center, Central Arizona College and Cobre Valley Institute of Technology for their leadership and support to help get this program off the ground.

One particular challenge we have encountered is well beyond the town's control, and that is the U.S. Congress' delay in approving a budget, which has in turn caused delays for our Waste Water **Treatment Plant** upgrades. These delays are costly to the town and the long term progress of the overall project. At this time, we do not have an estimated time frame for when the construction will be completed. Until the construction project is completed, we have been unable to provide our effluent water to the school district. This truly is a huge

concern for the town, and we have been in contact with our Arizona Congressional delegation about this situation. We will continue to persevere and use our own political capital as well as that of our many community partners to vigorously advocate for the approval of a budget that includes the funding for this critical infrastructure improvement.

Our team at the Town of Superior continues to work diligently on our day to day operations along with dozens of special projects and initiatives. This new year will undoubtedly present even more opportunities and of course challenges, and I am confident our staff and Town Council will continue to lead us toward an even brighter future that benefits all members of the Superior community.



The combined \$44.7 million project will require multiple full highway closures on US 60 between Superior and Miami for blasting operations as crews work to construct new bridges over Queen Creek and Waterfall Canyon.


Motorists should plan for as many as three closures a week, starting at a date to be determined within the next several weeks, and continuing until autumn. The closures, when required, will occur from 9 a.m. to 2 p.m.

Tuesdays, Wednesdays and Thursdays.

During the closures for blasting, crews will work to shift the highway 65 feet to the east and align it with the new Queen Creek Bridge. Also during the closures, crews will reconstruct the Waterfall Canyon Bridge just east of the Queen Creek Tunnel.

During the closures, motorists will detour on state routes 77 and 177 through Winkelman. This will add up

This aging bridge east of Superior will be replaced. Construction begins soon.



It's official.



Beginning the ceremony was Rebuild Superior's president Manny Guzman, who said, "This has been a long time coming with a lot of partners involved to be able to inaugurate this space. I think it was two years ago that we celebrated returning the building to the town government and the people of Superior. It is a blessing to be here to restore it to its place. This is the first time in 24 years that a course for credit is being offered at this complex, so let's celebrate that."

"Today is a culmination of so many wonderful things," said Superior Mayor Mila Besich. She continued, "Our council wanted to, at first, build a new building out by the current school district, and Todd told us very soon, 'You don't have the money to do the Earth work', and we started down the road building our partnership with Resolution, which officially began right before Valentine's Day in 2019, with agreements that were really unique and bold for any mining company to contribute to. We started designing a multi-gen center, and it was going to go to our Junior High, where town hall is at now. And COVID happened. And rapid inflation happened. And this dream pretty much almost fell off the rails. We almost didn't think it was going to happen.

"When council took another bold move, and suggested let's talk to Mr. Cardon, and see if he would sell us the (old high school) building, and here we are today on what is a new ribbon cutting, and there will be several because the building isn't done yet, but our commitment and vision is to empower our local residents, to help our young people to be able to stay here. As Manny said, our community has not had access to skilled job training without having to travel outside of this community for 24 years.

Besich called for a round of applause for everyone who made the new welding center a reality.

Closing out the speaking section of the ceremony was the Enterprise Center's Director Arlynn Godinez.

"To build something like this, as impactful as this," she said, "there are so many people to thank, because it wouldn't come about without the partnerships we've developed.

In developing this program we worked with Central Arizona College and Cobra Valley Institute of Technology. We started small, we started with just 10 participants, but our vision is much larger than that, and with the partnerships we've developed, and the core that we've developed, I think the sky is the limit. This is just one aspect of a greater vision that we have, our hope is that we can be the hub for workforce development for the entire region, and that's what we're going to work tirelessly to do."

Another ribbon cut, celebrating Superior's and the region's continuing quest for a thriving and prosperous future. Congratulations to the Town of Superior and the Superior Enterprise Center on the welding program and facility, continue to do great things!

to one hour to the trip between Globe and Superior. By providing consistent days and times for these full closures, ADOT is providing a reliable schedule for those who travel between the Superior and Globe areas

Toward the end of the project, a multiday closure of US 60 will be required to finish realigning the highway with the new Queen Creek Bridge.

The new Queen Creek Bridge will span 763 feet and feature one lane of travel in each direction with 4-foot-wide shoulders. The replacement structure for the Waterfall Canyon Bridge will span 107 feet.

Once the Queen Creek Bridge is completed, crews will dismantle the existing structure, which opened to traffic in 1949. While the bridge remains safe for traffic, it has reached the end of its lifespan and doesn't meet current standards for bridge design.

For safety reasons, construction will require closing some areas used by hikers, rock climbers and other recreational areas. In the Queen Creek Bridge area, trails will close from Magma Avenue in Superior to the west of the Claypool Tunnel. The trail through the Claypool Tunnel, heading east past Waterfall Canyon Bridge, will remain open until later in the project when active construction begins in this area.

In the Waterfall Canyon Bridge area, the US 60 pullout east of the Queen Creek tunnel will close during the project. Other nearby pullouts may close intermittently.
