Virginia Mayo and a Mammoth Ranch

The famous actress Virginia Mayo and her husband, Michael O'Shea owned a 6,000-acre ranch just outside of the Town of Mammoth. The ranch was purchased in 1950 then leased and finally sold some time in the mid-1950s. It became the Nevitt Ranch which is now owned by the Nature Conservancy. Virginia and Michael were originally looking for a ranch in Oracle but found that prices were high as owners were speculating on property values with the impending purchase of land by Magma Copper Company for the townsite of what became San Manuel.

In the late 1940s and early 1950s, Virginia Mayo was one of the biggest box-office draws at the movies. She appeared in the 1940s Oscar-winning The Best Years of Our Lives and the classic gangster film White Heat with James Cagney. She made numerous films and appeared with actors Danny Kaye, Bob Hope, Burt Lancaster, George Raft, Gregory Peck, Joel McCrea, Alan Ladd, Kirk Douglas and Ronald Reagan.

She met her husband Michael O'Shea in 1943 when they co-starred in the movie Jack London. O'Shea was married at the time to Grace Watts and had two children. They would divorce in 1947 and Michael would marry Virginia the same year. They would stay married until O'Shea's death in 1973. O'Shea's acting career lasted from the 1940s through the 1960s. Although he appeared as a supporting actor most of his career, he starred in some film noir pictures and had his own television comedy series, It's a Great Life, 1954 - 1956.

Reggie Ramsay of Oracle remembers seeing Virginia Mayo at the Blue Mist Motel in Florence, Arizona back in the 1950s. Reggie was attending high school in Florence back then. He said that he had hoped she would use the motel pool so he could catch a glimpse of her in her bathing suit.

Chuck Davis, a former resident of Mammoth in the 1950s knew the O'Sheas as a young boy. Chuck's parents owned the Mammoth Mercantile grocery store. It was there that Chuck met Michael O'Shea. The O'Sheas also hosted his family at their ranch where Chuck rode one of


Miners claim six team wins at multi-meet





Mammoth Memories: Chuck Davis

Chuck Davis is a former resident of Mammoth where his parents owned the Davis Mercantile. He has recently shared some of his memories of growing up in Mammoth during the 1940s and '50s on some Facebook pages. The following remembrance includes a story about a famous Hollywood couple that owned a ranch just outside Mammoth. This ranch would later become the Nevitt ranch. Here is Chuck's story:

Davis Mercantile burned to the ground in 1953. I firmly remember standing with dad and mom in the middle of the night, still in night clothes, speechless, staring at the roaring destruction from their bedroom window. The family business, owned and operated by my parents, Al and Clyde Davis, became a jumble of ashes, charred lumber, and mounds of collapsed adobe walls. The stench of scorched and rotting produce and meat fouled the air and depressed us. A small grocery store a few buildings south was soon purchased by my parents and became a temporary market while the Mercantile was rebuilt. If my memory is accurate, I think the store had been Barton's Market.

Our new building of cinder block on a concrete floor was nice and smelled fresh...as new concrete does. Out front, a building

length concrete floored porch with a shady roof completed the new Davis Mammoth Mercantile's welcoming personality. On that porch Michael O'Shea taught me how to wear my hat. "The brim," he instructed, "must be no more than the width of two fingers above the top of your nose. That's the way real cowboys do it." He took my hand placed my index and middle finger together, situated them, settled the brim down accurately and said, "there." I didn't know the man, just that he and his wife were new to the area. I didn't know then that Michael O'Shea was a successful Hollywood character actor or his pretty wife, actress

Virginia Mayo, was the top box office attraction of the 1940s.

He was a nice man. They were a nice couple. Who cared if he and his movie star wife were big time Hollywood movie stars. To me, a non-star struck kid, they were just nice regular adults living on a ranch several miles north of town between the highway and the river bed.

On a warm Sunday afternoon our family clambered onto dad's huge 1920s vintage American La France firetruck and paid our new neighbors a visit. They had a horse, a big, retired, high-spirited thoroughbred racer.

Mr. O'Shea saddled the pretty, long-legged mare and boosted me aboard.

The stirrups were too long for my short legs, my feet dangled. Then, for whatever reason, the mare spooked and ran hard for a nearby mesquite thicket, where she stopped suddenly before I would have been swept off by low limbs. At age 12, I was a helpless horse handling novice. I released the reins and gripped the saddle horn for my life's sake until the mare stopped in the thicket. No harm was done.

When calm returned, reassurance took over, stirrups were adjusted, panic was history, and I rode on thanks to the calm demeanor of Michael O'Shea. After that minor ordeal it became a pleasant Mammoth afternoon at the movie star's ranch.
