


She had worked first in Tucson, AZ

Pinal County courting voters for approval of road tax renewal

On Feb. 22, Pinal County staff, including Tara Harman, senior transportation planner, and District 4 Supervisor Jeff McClure, hosted an open house at the San Manuel Community Center. The meeting was to discuss and bring awareness to the Preserving Our Future effort.

Originally passed in 1986, and renewed in 2005, Pinal County's Half-Cent Road Fund is local funding used to preserve and build roads through the county. The Half-Cent Road Fund is the only funding for the Transportation Improvement and Maintenance Program, which develops five-year transportation plans, and reviews citizen submitted roadway improvement recommendations. The fund is currently set to expire in 2026, so Pinal County is bringing attention to the fate the county and its roads could face if the funding expires.

Tara Harman also informed those in attendance that if they have a suggested road that needs work, they can

submit a Transportation Project Request. Those requests must be for county-maintained roads only and can be submitted at https://www.pinal.gov/848/Project-Request-Form. More information on the Preserving Our Future awareness effort and the Transportation Improvement and Maintenance Program can be found at Preservingpinal.com.




