





Group activities will include fishing, hiking, swimming, volleyball and horseshoes in your free time.

The camp will be held from July 11th-15th and the tuition is \$200 per student. Financial assistance is available. Indicate on the application if it is needed. All youth who are entering grades 8-12 in the autumn of 2024 are eligible to apply. Applications must be postmarked no later than May 1,2024and must include a \$100 deposit. Applicants will be notified

of selection results no later than June
1. Upon notification of acceptance,
the remaining \$100 fee is to be paid
unless other aid has been requested and
awarded. No applicant will be denied
attendance because of financial need.
Selection is made based on the merit of
the application.

First bird walk in Dudleyville well attended

Have you ever taken the time to stop and listen to the birds chirping around you? I bet you didn't know that there might be more than 10, maybe 20 different species in your area, did you? If you find joy in watching birds and identifying the multiple species out in the Arizona nature, then you might be interested in birdwatching. Birding is becoming a popular hobby for tourists coming to our state, which helps boost local economies. It is also a great way to connect with, and respectfully observe nature, and the many avian species that reside in beautiful southern Arizona.

On Saturday, March 23, Pinal County Parks and Trails hosted a Birding Walk in Dudleyville. There on behalf on Pinal County Parks and Trails was Kelly Fox. The group of participants met up at the Dudleyville Multigenerational Center. Participants came from all over including Oracle, Globe, Florence, Saddlebrooke Ranch, Casa Grande and Arizona City. Since this birding walk was the first one, it was designed for beginners who were a little more new to the hobby of birding. There were about 14 participants in the group, with binoculars ready, the walk began, led by birding enthusiast Tim DeJonghe.

Predominantly going around different sections of the park, then going into a nearby wash, there were plenty of different birds to be seen, from cardinals to vermilions to Gila woodpeckers, roadrunners and more. Within a one-to-two-mile radius, the group was able to hear and/or sight up to 36 different bird species.

Birding enthusiast and Oracle resident Craig Anderson had a comment on the etiquette of birding.

"Birders need to respect and not disturb nesting areas and habitats. We need to respect residences, out-buildings, and livestock. We need to honor all notrespassing and private property signs, do not cross fences unless invited to do so, and close all gates behind us. Try and avoid using playback devices, unless doing official birding surveys," he said.

If you are interested in birdwatching,

be sure to look out for more local birdwatching events that are taking place in the surrounding communities. There are also plenty of internet resources that can give you tips, and local locations for birdwatching activities.
